- **Gayatri Balasamy vs M/S ISG Novasoft Technologies Limited (2025 SCC OnLine SC 986)**: Represented Government of India in a Constitutional Bench matter before the Supreme Court of India pertaining to power of courts to modify arbitral awards in setting-aside proceedings.
- **CORE v. ECI SPIC SMO MCML (JV) (2024 SCC OnLine SC 3219)**: Represented the Government of India in a Constitutional Bench matter before the Supreme Court of India pertaining to validity of appointment process which mandates a party to select an arbitrator from the panel curated by the other party.
- **Tomorrow Sales Agency Pvt. Ltd. v. SBS Holdings, Inc. & Ors. (2023 SCC OnLine Del 3191)**: Successfully represented the third-party funder in the landmark case pertaining to enforcement of SIAC Award against third party funder wherein the court held that an adverse award/costs cannot be enforced against a third party funder who is neither a party to the arbitration agreement nor a party in the arbitral proceedings.
- **Splendor Landbase Ltd. v. Aparna Ashram Society and Another read with Spacio Interspace v. TE Hospitality and Estates Ltd. (2023 SCC OnLine Del 5148)**: Assisted the Delhi High Court as an amicus curiae in an arbitration matter



involving *inter alia* the issue of filing of a stamped arbitration agreement in an application for appointment of arbitrator and the procedure to do the same.

- ***Ruia Exports & Anr. v. Moneywise Financial Services Pvt. Ltd. & Ors.* [O.M.P. (COMM.) 16/2020]**: Assisted the Delhi High Court as an amicus curiae in an arbitration matter involving the issue as to whether the proviso to Section 12(5) of the Arbitration and Conciliation Act, 1996 allows for the waiver of the applicability of Section 12(5) by the conduct of a party, even when there is no express agreement in writing to that effect.
- ***In Re: Interplay between Arbitration Agreements under the Arbitration and Conciliation Act, 1996 and the Indian Stamp Act, 1899* (2023 SCC OnLine SC 1666)**: Supreme Court case deciding that an instrument which is unstamped or insufficiently stamped would be inadmissible in evidence, however, the same is a curable defect and that in itself does not make the arbitration agreement void or unenforceable.
- ***Sai Guru Mega Solar Park Pvt. Ltd. & Anr. V. Union Of India, Through The Ministry of New and Renewable Energy & Anr.* (2020 SCC OnLine Bom 7627)**: Successfully represented the Applicant before Bombay High Court case involving development of solar power projects wherein the court held that where it is clear that the civil dispute involves question of fraud and misrepresentation, the mere fact that criminal proceedings can or have been instituted would not lead to the conclusion that a dispute that is otherwise arbitrable ceases to be so.
- ***M/s. Shriram EPC Ltd. v. Rioglass Solar SA* (2018) 18 SCC 313**: Successfully represented the Respondent in the Supreme Court case pertaining to enforcement of an ICC award (delivered in London) in India whereby the court held that there is no legal requirement of stamping of a foreign award for enforcing the same in India under Sections 48 and 49 of the Arbitration and Conciliation Act, 1996 on the basis that the Indian Stamp Act does not specifically include foreign award in its definition of award.
- ***M/s Ramky Infrastructure Pvt. Ltd. v. Micro and Small Enterprises Facilitation Council & Anr.* (2018 SCC OnLine Del 9671)**: Successfully represented the Respondent before the Delhi High Court case pertaining to a reference to arbitration by Facilitation Council under the Micro Small and Medium Enterprises Development Act, 2006 (“**MSMED Act**”) wherein the court held that for a supplier to be governed under the MSMED Act, it is not mandatory to file the Memorandum under Section 8(1) of the MSMED Act.
- ***Bharat Aluminium Company v. Kaiser Aluminium Technical Services Inc.* (2012) 9 SCC 552**: Successfully represented one of the respondents before the Supreme Court. The court held that the scheme of the Arbitration and Conciliation Act, 1996 makes a clear distinction on the applicability of Part I (Arbitration) and Part II (Enforcement of Certain Foreign Awards) of the said Act, i.e., Part I of the Act does not apply to foreign-seated arbitrations.
